brokerage receivable by the Bank _____


2. The Bank may in its absolute discretion _____

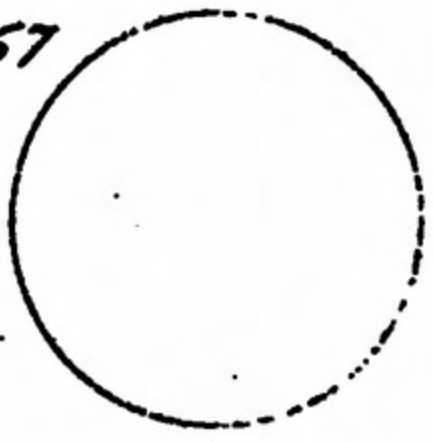
